


UN support to Philippine Government efforts for SDG acceleration

(September 2023)



BACKGROUND

In the lead up to the SDG Summit in New York on 18-19 September 2023, the UN Secretary-General has urged world leaders to help deliver a 'Rescue Plan for People and Planet' at the Summit announcing national and global commitments that will help drive SDG transformation for inclusion and sustainability. This document presents a brief summary of ongoing and planned interventions in the forthcoming Philippines 2024-2028 United Nations Sustainable Development Cooperation Framework supporting various Philippine Government initiatives that may be considered as [Transformative Actions](#) to accelerate SDG progress in the country. UN contributions are presented in line with the crucial dimensions for SDG acceleration being applied for the SDG Summit (see figure on right).
